2009-10 & 2010-11****SUMMARY**

1. This letter is issued to follow up the overall Local Government Finance Settlement announced in Parliament last week. It notifies local authorities of both their adults' Personal Social Services (PSS) specific revenue and capital grant funding and the Department of Health's contributions to the new Area Based Grant in support of social care policies, including children's PSS funding insofar as this is provided by the Child & Adolescent Mental Health Services (CAMHS) contribution. Details of individual funding stream allocations (where these are available), and a brief description of each area, appear in the relevant annexes. It is important for this circular to be brought to the attention of your lead members on adult social care.
2. In addition to CAMHS, the funding streams in support of Carers and Local Involvement Networks (LINKs) contributed by the Department of Health are intended to support both children and adults' services. It is therefore important for this circular to be brought to the immediate attention of those responsible for children's services.

ACTION

3. This letter is provided for information only, and should be read in conjunction with a similar circular issued by the Department for Children, Schools and Families (DCSF) [LAC reference 1810070005] in respect of children's PSS funding.

THE LOCAL GOVERNMENT FINANCE SETTLEMENT FOR 2008-09, 2009-10 AND 2010-11

4. For the first time, this circular provides details, at local authority level, of the adults' social care settlement for the next three financial years, aligned with the Spending Review cycle. This is in line with the Government's commitment to introduce multi-year settlements, which should encourage both certainty of funding and opportunities for improved budget planning within local authorities.
5. This circular provides details of actual local authority allocations for 2008-09 and provisional allocations in respect of 2009-10 and 2010-11. Separate Local Government Finance Reports will be issued on subsequent dates to confirm the allocations for 2009-10 and 2010-11. However, final allocations for 2009-10 and 2010-11 are unlikely to change materially from the provisional figures released today.
6. Adult social services are funded by general Formula Grant distributed by central Government and by each council's revenue. Precise details of the general Formula Grant allocation methodology can be found on the Communities and Local Government (CLG) website at:

7. Suggested changes to funding formulae were consulted on by CLG over the summer. The only changes to the Relative Needs Formulae (RNFs) for the two adult social care service blocks are an update of the Low Income Adjustment (LIA) in the older people's formula (consultation option SSE2) and the Area Cost Adjustment in both formulae, as well as updates to the data. The transitional damping applied to the new younger adults' RNF has also ended. The only changes to the Children's RNF are an updated Area Cost Adjustment and use of new data. The transitional damping applied to the Children's RNF has also ended. Further information is available in the technical guide to the personal social services funding formula, available on the CLG website.
8. From April 2008, the majority of revenue grants will be delivered to local authorities through the Department of Health's contribution to the new Area Based Grant. This Area Based Grant replaces the current Local Area Agreement grant as outlined in the 2006 Local Government White Paper, but is paid on an unringfenced basis to all local authorities. As such local authorities are able to determine locally how best to spend the Grant in order to deliver local and national priorities in their areas. As an unringfenced grant, there are no restrictions on carry forward between financial years.
9. This represents a considerable increase in the flexibility open to local government to take local spending decisions in line with the new performance framework. The Area Based Grant will be administered by CLG and paid to local authorities on a monthly basis. Further guidance was included in the Local Area Agreement phase two operational guidance, which is available at www.communities.gov.uk.
10. The Isles of Scilly will no longer receive their main revenue support grant through the same process as other authorities. Full details of this are available in the CLG guidance. Where Department of Health (DH) specific grants and contributions to the

ABG are allocated using the RNFs, this will continue to apply to all authorities including the Isles of Scilly.

KEY FEATURES OF THE ADULTS' PSS SETTLEMENT

11. DH will make available the following in 2008-09:

- a. Over £1 billion of revenue funding through £117.8 million of specific formula grants and £942.970 million contribution to the Area Based Grant;
- b. £69.1 million in capital funding.

12. DH will make available the following in 2009-10:

- a. Over £1.2 billion of revenue funding through £246.8 million of specific formula grants and £968.291 million contribution to the Area Based Grant;
- b. £70.1 million in capital funding.

11. DH will make available the following in 2010-11:

- a. Over £1.3 billion of revenue funding through £315.5 million of specific formula grants and £987.744 million contribution to the Area Based Grant;
- b. £71.1 million in capital funding.

12. The following annexes provide full details of the DH settlement:

- Annex A provides a summary of total Adults' PSS funding for 2008-09, 2009-10 and 2010-11, and details Children's PSS funding insofar as this is covered by the CAMHS Grant.
- Annex B provides details of actual funding allocations for each authority in 2008-09, where details are available.
- Annex C provides details of provisional funding allocations for 2009-10. These will be confirmed subsequently by a separate Local Government Finance Report.
- Annex D provides details of provisional funding allocations for 2010-11. These will be confirmed subsequently by a separate Local Government Finance Report.
- Annex E provides a brief description of the scope and purpose of each funding stream.

13. Adults' PSS grant allocations are provisional and subject to Parliamentary approval.

SPECIFIC FORMULA GRANTS – POINTS TO NOTE

14. Annex E provides a brief description of the scope, purpose and allocation method for each social care funding stream. Local authority level allocations for all three years are given in Annexes B, C and D. During the next three years, three revenue grants will be issued with conditions: AIDS Support, Social Care Reform Grant and Learning Disabilities Campus Closure Programme. All other revenue funding streams are now contributions to the new Area Based Grant, described in paragraphs 8-9 above.

15. Circulars giving details of each ringfenced specific grant will be issued shortly. You are asked to note the following in particular:

- **AIDS Support Grant** – Annex A indicates the overall level of funding for this grant in 2008-09, 2009-10 and 2010-11. As has been the case in previous years, we cannot notify local authorities of their individual allocations as part of today's announcement, because revised case load data will not become available until later in each year. Allocations of this grant for 2008-09 will therefore be calculated and announced in spring 2008, and similarly for subsequent years.
 - **Learning Disabilities Campus Closure Programme** – Annex A indicates the overall level of funding for this grant in 2008-09, 2009-10 and 2010-11. The grant will be targeted on local authorities in which campuses are currently or have previously been located. The department is working to develop an appropriate formula to allow this targeted allocation. Allocations of this grant for the three years will therefore be calculated and announced in spring 2008.
16. DH will make contributions to the new Area Based Grant in respect of the following policy areas:
- Adult Social Care Workforce
 - Carers
 - Child and Adolescent Mental Health Services
 - Learning Disability Development Fund
 - Local Involvement Networks
 - Mental Capacity Act and Independent Mental Capacity Advocate Service
 - Mental Health
 - Preserved Rights
17. The total funding to be provided for each of these areas is shown in annex A, the allocation to individual local authorities for the three years in annexes B, C and D and more detail on the scope and purpose of each is shown in annex E.
18. In line with Government policy on devolution and increasing flexibility for local decision making, we have rolled two previous grants (Access and Systems Capacity and Delayed Discharges) into RSG from 2008-09. Additionally, grants which were time-limited for the SR04 period are no longer included.

CAPITAL PROVISION

19. DH will make a contribution to the Single Capital Pot to the value of £27.727 million in all three years for adults' social care. The distribution to local authorities is based on the formula used in previous financial years, and is being announced at the same time as the revenue allocation.
20. DH will make a contribution to the Single Capital Pot to the value of £22.593 million in all three years for mental health services. This will be distributed on the basis of a basic amount of £50,000 to each council with the remainder allocated using the younger adults' RNF.
21. Levels per local authority of these contributions to the single capital pot will be notified in a separate letter [LASSL (DH)(2007)3].

22. DH will be allocating five capital grants over the period:

- **AIDS/HIV** – This ringfenced grant will provide a total of £9.3 million, in the proportion of £3.1 million for each of the three years, to support Local Authority HIV Capital Schemes. Further details of the bidding process will be provided in early 2008.
- **Extra Care Housing Grant** - This £80 million grant will be issued to local authorities and their housing partners during the next two years, in the proportion of £40 million in 2008-09 and £40 million in 2009-10. Further details of the bidding process will be provided in early 2008.
- **Infrastructure Support** – This £40 million grant will be issued in 2010-11. Further details of the bidding process will be provided nearer the time.
- **Common Assessment Framework** – This ringfenced grant will provide a total of £33 million, in the proportion of £11 million per year for each of the three years, to support a small number of demonstrator sites to develop the Common Assessment Framework (CAF). Further details of the bidding process will be provided in early 2008.
- **Social Care IT infrastructure** – This capital grant of £48 million, in the proportion £15 million in 2008-09, £16 million in 2009-10 and £17 million in 2010-11, will be allocated to local authorities to continue to allow them to develop their IT infrastructure and to enable rapid rollout of the CAF from 2011 following the completion of the demonstrator phase. Further details of the bidding process will be provided in early 2008.

CANCELLATION OF CIRCULARS

23. This circular should be cancelled on 31 March 2011.

RINGFENCED SPECIFIC GRANTS**AIDS Support Grant (£19.8m in 2008-09, £21.8m in 2009-10 & £ 25.5m in 2010-11)**

The AIDS Support Grant helps local authorities to support social care packages for people living with HIV/AIDS (and where appropriate, their partners, carers and families). The grant enables those with HIV to live independently in the community for as long as possible, and assists with the cost of HIV training for relevant social workers.

As established in 2004-05, 70% of the allocation is based on HIV caseload in a local authority area, and 30% on the number of women and children living with HIV in a local authority area. Allocations will be based on the most recently available HIV caseload data by local authority area of residence, to be provided by the Health Protection Agency (HPA) later each year.

Learning Disabilities Campus Closure Programme (£14m in 2008-09, £31m in 2009-10 & £51m in 2010-11)

The White Paper *Our health, our care, our say* (2006) said that NHS residential accommodation (also known as NHS campuses) should be closed by 2010. This programme of work has begun in parts of the country following the 2001 White Paper *Valuing People: A new Strategy for Learning Disability for the 21st Century* and LAC(2001)23 which both gave a clear expectation that people in the old long stay hospitals or in campus accommodation would move to housing in the community. To help with this transition for those PCTs with campus accommodation, targeted capital support has been provided to ensure that re-provision happens effectively across the country.

This ringfenced revenue grant over the three years is designed to provide some help with the additional revenue costs that will be incurred with the move from campus to community accommodation. Local authorities will be asked to work in partnership with PCTs to establish a baseline on which to allocate the revenue grant over the period.

The grant will be targeted on local authorities in which campuses are currently or have previously been located. The department is working to develop an appropriate formula to allow this targeted allocation. Allocations of this grant for the three years will therefore be calculated and announced in spring 2008.

Social Care Reform Grant (£84m in 2008-09, £194m in 2009-10 & £239m in 2010-11)

The White Paper *Our health, our care, our say* (2006) consultations told us that people want adult social care services to focus on increasing people's independence and promote inclusion in communities through early intervention and promotion of well-being. The ambition is to meet this aspiration through a radical reform of social care and make personalisation the cornerstone of social services. What this means is every person receiving support, in whatever setting, having choice and control over the shape of that support.

The new, ringfenced Social Care Reform Grant will make over half a billion pounds available over the next 3 years to help councils with social services responsibilities to redesign and reshape their systems to enable them to deliver this transformation. This revenue Grant also includes money from resources secured in CSR07 for the NHS to recognise the positive impact investing in social care can have on peoples' health and the demand for healthcare. The Department of Health, with the agreement of sector leaders, will top-slice £2m per year of the Grant to facilitate sector-led regional implementation.

This ringfenced specific grant will be allocated according to an authority's proportional share of the total adults' Relative Needs Formula, with a minimum allocation of £10,000. It will be paid under section 31 of the Local Government Finance Act 2003. Details of allocations and conditions associated will be available in a separate Local Authority Circular [LAC(DH)(2007)8] in early December.

COMPONENTS OF AREA BASED GRANT

DH contributions to the Area Based Grant will be paid under section 31 of the Local Government Finance Act 2003.

Adult Social Care Workforce (£139m in 2008-09, £143m in 2009-10 & £147m in 2010-11)

This funding stream replaces the resources provided through the adult services parts of the National Training Strategy and Human Resources Development Strategy Grants and is designed, as in previous years, to support workforce development in the adult social care workforce in the statutory, private and voluntary sectors. A £7 million top slice, not transferred to ABG, will continue to be used to promote regional work based learning.

The funding is allocated according to an authority's proportional share of the total adults' Relative Needs Formula.

Carers (£224m in 2008-09, £240m in 2009-10 & £256m in 2010-11)

The main purpose of the funding provided for Carers is to:

- enhance provision of community care and children's services to allow carers to take a break from caring by stimulating greater diversity of provision
- stimulate a greater awareness by authorities of the need for services in their area to be more responsive to the needs of carers; and
- provide carers with services other than breaks, in keeping with the 2001 Carers and Disabled Persons Act.

As in previous years, 20% has been allocated using the local authority level proportions derived from the children's Relative Needs Formula (RNF), 24% using the younger adults' (18-64) RNF and the remaining 56% using the older people's RNF. The split between client groups is derived from the 1995 General Household Survey of informal carers.

Child and Adolescent Mental Health Services (CAMHS) (£94.998m in 2008-09, £100.045m in 2009-10 & £105.036m in 2010-11)

The Department of Health and the Department for Children, Schools and Families are working together to improve and expand CAMHS. The funding contributed to the ABG is designed to improve CAMH services, in accordance with local needs and priorities, as set out in the CAMHS Development Strategy. This should respect the description of a comprehensive CAMHS as set out in the Children's NSF. Such a service should include mental health promotion and early intervention.

Plans for developing CAMHS should be agreed between Social Services, Primary Care Trusts, Education Departments and other partners. Local agencies should work in partnership at all levels of service planning and delivery. Joint commissioning arrangements and/or Health Act flexibilities should be used wherever possible.

£2.35/£2.45/£2.55 million in each year respectively not transferred to ABG will be used to fund the National CAMHS Support Service and NSF Service Developments to test the approach to developing services as set out in *Every Child Matters* and the Children's NSF. The CAMHS Standard of the Children's National Service Framework provides a definition of a comprehensive CAMH service which is an essential component of the modernisation of services envisaged in *Every Child Matters*.

Up to 5% of the funding may be spent on capital projects including the development of IT infrastructure and investment in the built environment.

This funding is allocated by DH in relation to children's social care, according to the children's social care Relative Needs Formula.

Learning Disability Development Fund (£43.752m in 2008-09, £43.752m in 2009-10 & £43.752m in 2010-11)

The Learning Disability Development Fund (LDDF) was created to support local implementation of the agenda set out in the learning disability white paper, *Valuing People* (2001), and until 2007/8 has been allocated to PCTs for local learning disability partnership boards to determine its allocation. In recognition of the lead role of local authorities on learning disabilities, the funding will be provided directly to local authorities through ABG (rather than through PCTs) to support local authorities in delivering the key outcomes for people with learning disabilities.

The funding is allocated according to an authority's proportional share of the younger adults' (18-64) Relative Needs Formula.

Local Involvement Networks (£27m in 2008-09, £27m in 2009-10 & £27m in 2010-11)

The Government aims to strengthen the ability of local communities to influence what health and social care services are provided and how they are run. Under the Local Government and Public Involvement in Health Act 2007, each local authority has a duty to make contractual arrangements for the involvement of people in the commissioning, provision and scrutiny of health services and social care services - i.e., to establish local involvement networks or LINKs. The allocations to support this are indicative of the sums the Department has identified as being appropriate (given the size and demographics of the local authority) for the procurement of a host for a LINK for each area.

The funding is distributed by allocating a basic amount of £60,000 to each authority and allocating the remainder according to an authority's proportional share of the total Relative Needs Formulae for adults' and children's social care.

Mental Capacity Act, Independent Mental Capacity Advocate Service and Deprivation of Liberty Safeguards (23.825m in 2008-09, £30.090m in 2009-10 & £28.926m in 2010-11)

The Mental Capacity Act 2005 came fully into force on 1st October 2007. The Department of Health is continuing to make resources available to assist Councils with Social Services Responsibilities (CSSRs) to:

1. Train staff across their Implementation Network to understand the implications of the Act and to act accordingly. The Department of Health has prepared standardised training materials which are available electronically.

2. Fund the Independent Mental Advocate service (IMCA) service. Its purpose is to help vulnerable people who lack capacity who are facing important decisions made by the NHS and Local Authorities about serious medical treatment and changes of residence. NHS bodies and Local Authorities have a duty, under the Act, to instruct and consult the IMCA in decisions involving people who have no family or friends. The IMCA service needs to be independent of both CSSRs and local health providers.

3. Resources for Increased Social Care Costs. The Department is making additional resources available for the increased social care costs of meeting the requirements of the Act. These have been identified as additional staff costs in carrying out assessments of capacity, case conferences and best interests decisions. There are some very good examples of new MCA posts being funded locally, which will now be easier as this funding is recurrent. Further good practice information will be issued.

4. Resources to plan for the implementation of the Deprivation of Liberty Safeguards. This will provide an opportunity to maintain and extend the work of existing local Mental Capacity Act implementation networks. These networks will be most effective if they work closely with representatives of care homes, hospitals and PCTs.

50% of the funding is allocated according to each authority's relative share of the younger adults' (18-64) Relative Needs Formulae (RNF), with the remaining 50% using the local authority level proportions derived from the older people's (65+) RNF.

Mental Health (£139.545m in 2008-09, £146.854m in 2009-10 & £154.180m in 2010-11)

Resources provided by this funding stream are designed to assist local authorities in developments to support implementation of Mental Health National Service Framework standards and other Mental Health service developments. Such investments will augment existing Mental Health expenditure.

The funding is allocated using the Younger Adults' Relative Needs Formula.

Preserved Rights (£260.2m in 2008-09, £247.0m in 2009-10 & £235.4m in 2010-11)

Since 8 April 2002 local authorities have been responsible for providing residential accommodation to persons ordinary resident in their area who were previously in relevant accommodation with Preserved Rights to higher rates of Income Support, as prescribed by

section 50(1) of the Health and Social Care Act 2001. The Preserved Rights funding is provided through the ABG to local authorities to help them discharge these responsibilities.

Preserved Rights resources are allocated to individual local authorities pro rata to the numbers of former Preserved Rights residents which each authority indicated that they supported in September 2002, multiplied by the area cost adjustment. Allocations are estimated separately for older and for younger residents.

The Preserved Rights funding is allocated by case load data, and is therefore not suitable for allocation by reference to an authority's relative share of the adults' social services Relative Needs Formula (RNF) control totals.

CAPITAL GRANTS

AIDS/HIV (3.1 m in 2008-09, £ 3.1m in 2009-10 & £ 3.1m in 2010-11)

HIV Capital Grant (HCG) funding is targeted at supporting HIV related capital schemes, with first priority given to the purchasing and refurbishing of properties, with appropriate support services to allow people with the virus to live independently in the community in line with overall Government policy. In addition, the HCG has been used to support the refurbishment of both voluntary sector and local authority premises, as well as purchasing IT equipment to underpin the integrated delivery of social care initiatives on the ground. Allocation is based on bids which are assessed on their merits and on how well they fit into the service development plans of sponsoring authorities. Further details of the bidding process will be provided in early 2008.

Extra Care Housing Grant (£40m in 2008-09 and £40m in 2009-10)

Extra care housing will provide older people with a safe and secure environment where they can live independently with access to flexible care and services. This grant will be issued to local authorities and their housing partners during the next two years. Allocation is based on bids submitted by local authorities in line with DH criteria. Further details of the bidding process will be provided in early 2008.

Infrastructure Support (£40m in 2010-11)

This funding will enable further capital support to infrastructure to support delivery of adult social care services. Further details of the bidding process will be provided nearer the time.

Common Assessment Framework (£11m in 2008-09, £11m in 2009-10 & £11m in 2010-11)

This ringfenced grant will provide funding to support a small number of demonstrator sites to develop the Common Assessment Framework. Further details of the bidding process will be provided in early 2008.

Social Care IT Infrastructure (£15m in 2008-09, £16m in 2009-10 & £17m in 2010-11)

This funding will be allocated to local authorities to continue to allow them to develop their IT infrastructure and to enable rapid rollout of the CAF from 2011 following the completion of the demonstrator phase. Further details of the bidding process will be provided in early 2008.
